Head-Student Affairs/ One of the Members of the Committee from amongst the Non-Teaching employee shall act as Member Secretary of the Committee


The term of the office (tenure) of the members of the Internal Committee shall be for a period of three (3) years from the issuance of this notification (i.e. upto 23rd June, 2022).
